

ELIGIBILITY

- Commercial, industrial, institutional and multifamily facilities in New Jersey that contribute to the Societal Benefits Charge fund.
- CHP or Fuel Cell equipment must be new, commercially available, stationary, and permanently installed on the customer side of the meter.
- CHP or Fuel Cell systems with waste heat utilization must achieve annual system efficiency of at least 65% Lower Heating Value (LHV); electric only generation must achieve 50% LHV electrical efficiency.
- Natural gas, or in certain cases hydrogen, equipment is eligible.
- Biopower - renewable energy systems that produce electricity using organic material.

(Note: Applicants to NJCEP CHP program may be subject to additional interconnection requirements/approval and are solely responsible for obtaining all federal, state and local approvals.)

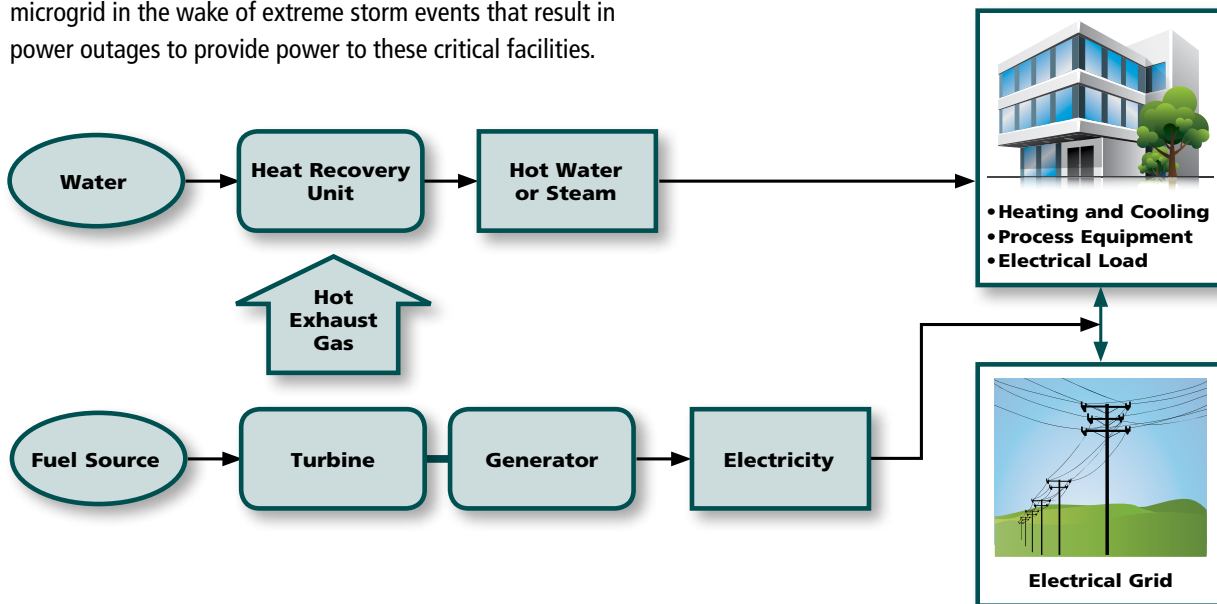
EFFICIENCY & RELIABILITY

Combined Heat and Power (CHP) is the concurrent production of electricity and useful thermal energy (heating and/or cooling) from a single fuel source, such as natural gas. CHP is a form of distributed generation located at or near the point of consumption. Typically, CHP systems are designed to meet the facility's thermal base load.

ECONOMICAL AND ENVIRONMENTAL BENEFITS

CHP offers a significant improvement in efficiency, requiring less fuel to produce the combined energy output. This results in substantial reductions in your company's energy bill and greenhouse gas emissions.

As an added benefit, most CHP/FC equipped facilities can be used to provide emergency services to the public during and after a major storm or other emergency. Facilities will be able to island from the distribution system and operate as a microgrid in the wake of extreme storm events that result in power outages to provide power to these critical facilities.



GET PAID FOR YOUR CHP PROJECT

The NJ Board of Public Utilities provides generous financial incentives for qualifying CHP installations. Eligible technologies include:

- **Combined Heat & Power - with non-renewable fuel source such as natural gas internal combustion engine, combustion turbine, or microturbine**
- **Fuel Cells - powered by non-renewable fuel source both with and without waste heat recovery**
- **Heat Recovery - powered by non-renewable fuel source, recovery of heat or other mechanical energy from existing equipment utilizing new electric generation equipment such as steam turbine**
- **Biopower - sustainable technologies using biomass for electricity production**

Combined Heat and Power System Candidates

Wondering if a CHP system is right for your company? The following types of facilities are often ideal candidates for an integrated system:

- **Local Government – Wastewater Treatment Plants, District Energy Systems**
- **Hospitality – Hotels, Casinos, Health Clubs**
- **Institutions – Colleges and Universities, Correctional Facilities**
- **Healthcare – Hospitals, Nursing Homes, Extended Care**
- **Industrial – Food Processing, Chemical, Paper and Glass Manufacturing, Pharmaceutical, Textile, Plastics, Commercial Laundries, and many more**
- **Residential – Multifamily Apartment Complexes and Planned Communities**
