On March 23, 2012, the OCE requested comments on a number of proposed changes to the NJCEP. One of the proposed changes concerned replacing T12 fixtures in schools. A high level summary of the proposed T12 replacement program was provided at that time. TRC has now developed a detailed proposal for the T12 school replacement program which is attached to this email.

The OCE is also proposing an additional change that was not included in the March summary of proposed program changes. Specifically, the National Association of State Energy Offices (NASEO) is a not-for-profit organization that coordinates efforts amongst State Energy Offices. The 2012 budget approved by the Board included funding for NASEO membership for 2011/2012 (NASEO FY12 which is October 1, 2011-September 30, 2012). In FY2010 and FY2011 the OCE participated in NASEO activities and attended NASEO conferences. The OCE believed that the State had paid NASEO membership fees for 2009/2010 and 2010/2011. However, the paperwork for authorizing payment of NASEO membership fees was inadvertently not processed. Therefore, Staff is recommending that the Board authorize two payments totaling \$13,490 to NASEO for FY2010 and FY2011 membership fees. The Board approved 2012 budget included \$100,000 for NASEO and other memberships which is sufficient to pay the proposed additional membership fees. Therefore, no changes to the budget are required to accommodate this proposal.

The OCE is requesting comments on these two proposed changes by COB Thursday, May 10, 2012. Staff anticipates that the proposed changes to the NJCEP will be considered by the Board at its May 23, 2012 agenda meeting. Comments should be emailed to:
