TED TURNER TO SERVE AS KEYNOTE SPEAKER AT THE 2007 CLEAN ENERGY CONFERENCE & LEADERSHIP AWARDS

Renewable Energy Investor to Lead Garden State with Climate Change Solutions

(NEWARK, NJ) – Ted Turner, entrepreneur and philanthropist, will headline the 2007 New Jersey Clean Energy Conference & Leadership Awards on September 28 in New Brunswick. Turner will address an audience of more than 600 leading businesses and energy professionals on this year's theme "Partnering for Climate Change Solutions."

"Our future depends on changing the way we use energy," said Turner. "We've got to move away from fossil fuels and develop long-term clean energy solutions that work. New Jersey understands this, and has put itself in a position to gain tremendous economic benefits from businesses that thrive in the state with the support of New Jersey's Clean Energy Program."

Turner, who recently partnered with Dome-Tech Solar to form DT Solar, a Turner renewable energy company, has made it a priority to address the topic of global warming and climate change issues that are facing our nation.

The 2007 New Jersey Clean Energy Conference & Leadership Awards will highlight New Jersey's clean energy goals and strategies to reduce greenhouse gases, increase the use of renewable energy and increase energy efficiency. Through its Clean Energy Program, which provides over \$180 million dollars each year to businesses, residents and municipalities, New Jersey has emerged as a national leader and one of the fastest growing solar markets in the country.

"New Jersey continues to break down barriers on the clean energy front, and this year is no exception," said NJBPU President Jeanne M. Fox. The conference will also feature the third annual New Jersey Clean Energy Leadership Awards, which recognize businesses, communities and other entities that have made powerful choices and lead the way in developing climate change solutions.
