### New Jersey to Re-launch Home Appliance Rebate Program in July

*Funding is available through the American Recovery and Reinvestment Act*

NEWARK, N.J. – The New Jersey Board of Public Utilities (NJBPUB) and *New Jersey’s Clean Energy Program™* today announced the continuation of the federally funded appliance rebate program, which will begin on July 1<sup>st</sup>. The rebate program, which originally ran throughout April, is part of funding the state received from the American Recovery and Reinvestment Act (ARRA), which is being used to encourage all New Jersey residents to purchase ENERGY STAR® qualified home appliances.

“These federally funded rebates will give all New Jersey residents an opportunity to upgrade their appliances to ENERGY STAR qualified models, which will help reduce their home energy usage,” said NJBPUB President Lee A. Solomon. “This program will help residents save money and protect the environment.”

The specific ENERGY STAR appliances, rebate amounts and product specifications, which will be offered from July 1, 2010 through August 31, 2010 – or while funding lasts – are as follows:

Clothes Washers	\$35	Clothes washers must have a modified energy factor (MEF) of 1.8 – 2.19.
Dishwashers*	\$25 or \$50	Customers receive a \$25 rebate for dishwashers that use 5.8 gallons of water or less per cycle and use less than 324 kWh per year.  Customers receive a \$50 rebate for dishwashers that use 5.0 gallons of water or less per cycle and use less than 307 kWh per year.

Refrigerators*	\$75 or \$100	<p>Customers receive a \$75 rebate if the refrigerator they purchase is 20 percent better than the federal standard; the refrigerators have to be 7.75 cubic feet or greater in volume.</p> <p>Customers receive a \$100 rebate if the refrigerator they purchase is 25 percent better than the federal standard; the refrigerators have to be 7.75 cubic feet or greater in volume.</p>

\* Compact dishwashers and refrigerators are not eligible for rebates.

These rebates are offered for a limited time and may end before August 31, 2010, based on availability of funds. The program will terminate the promotion when funds are exhausted. Program termination will be posted at [NJCleanEnergy.com](http://NJCleanEnergy.com).

In addition to the federally funded appliance rebates, *New Jersey's Clean Energy Program* also offers rebates for ENERGY STAR qualified clothes washers, dehumidifiers, and room air conditioners to eligible customers. Clothes Washers	\$50	For ENERGY STAR qualified products with an MEF of 2.2 or higher.
Dehumidifiers	\$25	All qualified ENERGY STAR dehumidifiers.
Room Air Conditioners	\$20	This is a seasonal rebate, which began May 14, 2010, and ends August 31, 2010. It covers all ENERGY STAR qualified room air conditioners.

*New Jersey's Clean Energy Program* also offers a year round, refrigerator/freezer recycling program, where eligible residents may be paid \$50 and receive convenient, free pick up of their old, working refrigerators or freezers. Customers taking advantage of the ARRA incentives on the purchase of new refrigerators may also take advantage of this program.
