- 2. Builder must be registered as a DOE Zero Energy Ready Home Partner by completing the Online DOE Partnership Agreement (available at http://www4.eere.energy.gov/buildings/residential/register and select "Builders").
- 3. Builder must be registered as an ENERGY STAR® Partner by completing the Online EPA Partnership Agreement (available at https://www.energystar.gov/index.cfm?fuseaction=opa.showPartnerRoles&p_code=HBUILDER and select "Builders").
- 4. Builder must complete program training prior to submitting homes for enrollment in the program.
- 5. Builder agrees to comply with and accurately represent all program requirements and benefits. Use of program name and logos require prior authorization by the program.
