
TAKE NOTICE THAT pursuant to the Open Public Meetings Act, N.J.S.A. 10:4-6 et seq., the New Jersey Board of Public Utilities (Board) has scheduled a hearing to receive comments on the New Jersey Clean Energy Program (NJCEP) Comprehensive Energy Efficiency and Renewable Energy Resource Analysis (CRA) for Fiscal Year (FY) 2017 and related programs and budgets for Fiscal Year 2017. The public hearing on the FY17 CRA and the program budgets and filings will take place on June 10, 2016, at the at the State House Annex, Committee Room 11, 125 West State Street, Trenton, NJ 08608 at 10:00 a.m. A brief presentation will be held on the CRA and the budgets and filings.

The FY17 CRA is a one-year planning document that explores New Jersey's achievable potential for energy savings, the costs associated with those savings, and future technology resources. The proposed CRA funding level and FY17 budget will fully fund the NJCEP programs that help residents, businesses and local governments reduce energy usage, save money and improve the environment.
