Eligible courses are designed to promote energy efficiency and decarbonization in New Jersey's new construction market.

These valuable certifications are the next steps to advancing your clean energy career or those of your employees, leading to success in energy-efficient, new construction projects.

Benefits



Acquiring new skills leads to new opportunities.

Taking training courses designed to gain in-depth knowledge of energy-efficient buildings in the future can help you develop the expertise needed to work on new construction projects.

Eligibility



Applicants must show proof of:

1. Residence in the State of New Jersey; OR
2. Principal place of work is in New Jersey; OR
3. A nexus to New Jersey and proof can be provided. *

Reimbursement



Up to \$2,000 will be reimbursed per person per course upon successful completion, with a maximum reimbursement of \$4,000 per fiscal year, from July 1 through June 30.

Submit an application

Follow the steps to create a user profile and application, upload documentation, and track your application status through the portal.



Receive pre-approval

Your application will be reviewed for eligibility. If pre-approved, you will receive a letter prior to taking the course to be eligible for reimbursement.*



Take the training course

Take your pre-approved training/certification course and any applicable exam(s).



Submit Proof

Submit proof of payment and course completion to the application portal.

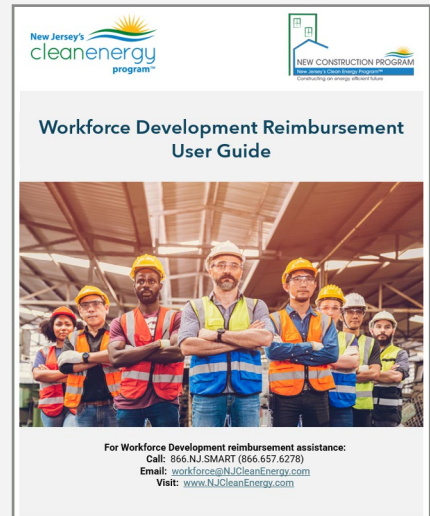


Receive final approval and reimbursement

After documentation review, your reimbursement will be issued.
