NEW JERSEY HELPS HOMEOWNERS BE ENERGY SMART AND SAVE UP TO 30 PERCENT ON ENERGY BILLS

Home Performance with ENERGY STAR®, part of New Jersey's Clean Energy Program™, Now Available to Improve Efficiency and Performance of Homes Statewide

(JACKSON, NJ) – For New Jersey residents concerned about rising energy costs, the impacts of global warming and the need to be more energy smart, a new statewide initiative called *Home Performance with ENERGY STAR®* can help them save up to 30 percent on their energy costs and improve the comfort, health and safety of their homes.

The New Jersey Board of Public Utilities (NJBP) and New Jersey's Clean Energy Program™, which sponsor the program, have expanded the program statewide.

“Our homes can be huge energy wasters and cause twice as much pollution as the average car,” said NJBP President Jeanne M. Fox. “Home Performance with ENERGY STAR is one of many Clean Energy Programs that New Jersey residents can use to save energy, reduce cost and help protect our state's natural resources.”

Home Performance with ENERGY STAR helps homeowners find accredited contractors who can deliver advanced energy efficiency improvements to their homes in order to save money, energy and the environment. Trained and accredited by the Building Performance Institute (BPI), contractors participating in the *Home Performance with ENERGY STAR* program specialize in heating and cooling equipment, insulation and air sealing, and comprehensive, computerized home analysis to help make homes as energy efficient, comfortable and safe as possible.

BPI-Accredited contractors take a comprehensive approach to home energy usage that looks at the whole house, not just one room or single problem area. The contractor will perform a Comprehensive Home Performance with ENERGY STAR Assessment to test a home's overall energy performance and draw up a plan to improve the home's energy efficiency and comfort.

Home Performance with ENERGY STAR contractors help residents repair or replace heating and cooling equipment, solve problems with cold and drafty rooms and help lower energy costs and improve comfort. Typical improvements pay for themselves because of increased energy efficiency and reduced energy bills. The initial assessment fee varies by contractor, and some contractors may deduct the assessment fee if the homeowner decides to implement the recommended improvements. The initiative offers low-interest financing options to help pay for making the improvements, and the state of New Jersey offers incentives on some eligible measures. Federal tax credits are also available on some home energy efficiency improvements.
