### **NJBPU AND NEW JERSEY NATURAL GAS MAKE SAVING ENERGY MORE AFFORDABLE**

*Incentives from Home Performance with ENERGY STAR<sup>®</sup>, part of New Jersey's Clean Energy Program<sup>™</sup>, help residents reduce household energy use and costs by up to 30 percent*

(TRENTON, NJ) – Starting today – and for a limited time, New Jersey Natural Gas customers may be eligible for new financial incentives to help pay for energy-efficiency home improvements through *Home Performance with ENERGY STAR<sup>®</sup>*, a program sponsored by the New Jersey Board of Public Utilities (NJBPU) and *New Jersey's Clean Energy Program<sup>™</sup>* that can help residents save up to 30 percent on their energy costs and improve the comfort, health and safety of their homes.

For a limited time the comprehensive home assessment is offered at a discounted price of \$250 (a \$500 value) through the *Home Performance with ENERGY STAR* Program. When energy efficiency improvements are completed, customers will be reimbursed for the amount of the home assessment fee and a matching \$250 rebate from New Jersey Natural Gas – on eligible measures for work totaling \$2,500 or more. Additional incentives include low-interest financing – with an APR as low as 3.99 percent, or as much as 50 percent back on recommended measures.

“These incentives will help residents fight climate change, reduce their initial investment in energy efficiency and save on monthly energy bills,” said Jeanne M. Fox, president of the NJBPU. “*Home Performance with ENERGY STAR* is one of many of New Jersey’s **Clean Energy** Programs that can help the State reduce its overall energy use 20 percent by 2020.”

According to the U.S. Environmental Protection Agency, up to half the energy used to heat and cool homes is wasted due to leaky ducts, inefficient equipment, poor insulation and air leaks. In addition, the typical home produces more greenhouse gas emissions, contributing to global warming, than the average car produces annually.
