Proposed Solar Stakeholder Schedule

The Summit Blue Report, "Analysis of Rate Payer Impacts of Alternatives for Transitioning the NJ Solar Market from Rebates to Market Based Incentives," provides an analysis of the potential impact on rate payers of transitioning from rebates to market based incentives based on the various models proposed by the REC work group. This report does not, as of yet, provide recommendations on the ACP and SACP levels for 2009 and 2010 or longer, or for the Solar REC-only Pilot. We are revising the stakeholder process and Hearing schedule to address this additional information, as follows:

May 23, 2007	OCE will post a Staff Straw Proposal on the BPU and CEP websites of recommendations for establishing an appropriate multi-year schedule that will develop a set of transition strategies while achieving the RPS targets and minimizing ratepayer impacts. This Proposal will be developed by OCE and Summit Blue based on comments received through the stakeholder process and the Summit Blue Report and will include any potential revisions to the current Solar REC-only Pilot.
