

PROGRAM GUIDELINES



- Applicant must be a customer of one of the following electric utilities:
 - Atlantic City Electric
 - JCP&L (First Energy)
 - PSE&G
 - Rockland Electric Company
- Only select refrigerator models purchased between October 1, 2020 and June 30, 2021 are eligible for a rebate. Please see the complete list at **NJCleanEnergy.com/FRIDGE**.
- Some retailers provide instant rebates at the register at the time of purchase. If you received the instant rebate, you are not eligible for this mail-in rebate. For a list of retailers that provide instant rebates, go to **NJCleanEnergy.com/RETAILERS**.
- Completed rebate application must be postmarked no later than 180 days from the purchase date.
- Application must be completed in its entirety, or it may be rejected. Rebate requests must be accompanied by a legible sales receipt, which specifies the purchase date, item purchased, and indicates it is paid in full.
- Unit must be new and installed in New Jersey.
- Rebates are issued in the form of a check from New Jersey's Clean Energy Program (NJCEP) and are subject to available funds.
- Please allow 120 days from the date NJCEP receives ALL required information to process your rebate.
- Program procedures, requirements, and rebate levels are subject to change or cancellation without notice.

To be eligible, refrigerators must be listed on NJCleanEnergy.com/FRIDGE.

Tier	Efficiency Criteria	Rebate
Compact (<7.75 cu ft) (Aligned with ENERGY STAR V5.0)	Baseline ENERGY STAR	\$25
Tier 1 (≥ 7.75 cu ft) (Aligned with ENERGY STAR V5.0)	Baseline ENERGY STAR	\$50
Tier 2 (Aligned with ENERGY STAR Most Efficient)	15% over the measured Federal Minimum Efficiency Standard	\$75
